**Community Relations
ACCESS TO RECORDS**

The County Superintendent and County Board recognize the right of members of the public to have access to public records. The County Superintendent and County Board intend to provide any person reasonable access to public records during normal business hours and within the requirements of law. Public access shall not be given to records that are exempt from public disclosure pursuant to the California Public Records Act or other state or federal law.

In response to a public records request, the County Superintendent or designee shall make reasonable efforts to locate the requested records, including, but not limited to, any electronic communication substantively related to the records, such as email, text messages, instant messages, and other electronic communications, regardless of whether they are transmitted through a device or account provided by the County Superintendent or the personal device or account of the County Superintendent, a County Board member, or a County Superintendent employee.

The County Superintendent and County Board may charge for copies of public records or other materials requested by individuals or groups, in accordance with law and as specified in Superintendent Administrative Regulation 1340.

In order to help maintain the security of the records of the County Superintendent and County Board, the County Superintendent or designee may require that members of the public who are granted access to examine records do so in the presence of a County Superintendent staff.
