

**FRESNO COUNTY SUPERINTENDENT OF SCHOOLS****Instruction****SELECTION AND EVALUATION OF INSTRUCTIONAL MATERIALS**Resolution On Sufficiency Of Instructional Materials

Whereas, the Fresno County Board of Education (County Board), in accordance with the requirements of Education Code section 60119, held a public hearing on *(date)*, at *(time)* o'clock, which is on or before the eighth week of school (between the first day that students attend school and the end of the eighth week from that day) and which did not take place during or immediately following school hours, and;

Whereas, the County Board provided at least 10 days notice of the public hearing by posting it in at least three public places stating the time, place, and purpose of the hearing, and;

Whereas, the County Board encouraged participation by parents/guardians, teachers, members of the community, and bargaining unit leaders in the public hearing, and;

Whereas, information provided at the public hearing detailed the extent to which sufficient textbooks or instructional materials were provided to all students, including English learners, in the Fresno County Superintendent of Schools (County Superintendent)/County Board schools, and;

Whereas, the definition of "sufficient textbooks or instructional materials" means that each student, including each English learner, has standards-aligned textbooks and/or instructional materials to use in class and to take home, which may include materials in a digital format as long as each student, at a minimum, has and can access the same materials in the class and at home as other students in the same class or course, but shall not include photocopied sheets from only a portion of a textbook or instructional materials copied to address a shortage, and;

Whereas, textbooks or instructional materials in core curriculum subjects should be aligned with state academic content standards and/or the Common Core State Standards adopted by the State Board of Education;

Finding of Sufficient Textbooks or Instructional Materials (*Resolution should contain this finding of sufficient textbooks/instructional materials or, in the alternative the finding below of insufficient textbooks/instructional materials*)

Therefore, be it resolved that for the *(year)* school year, the County Superintendent/County Board have provided each student, including each English learner, with sufficient standards-aligned textbooks or other instructional materials that are consistent with the cycles and content of the curriculum frameworks adopted by the State Board of Education in the following subjects: Mathematics, Science, History-Social Science, English Language Arts, World language, and Health;

Finding of Insufficient Textbooks or Instructional Materials in One or More Subjects (*Resolution should contain this finding of insufficient textbooks/instructional materials or, in the alternative the finding above of sufficient textbooks/instructional materials*)

Be it further resolved, that the following actions will be taken to ensure that all students have sufficient standards-aligned textbooks or instructional materials in all subjects that are consistent with the cycles and content of the curriculum frameworks within two months of the beginning of the school year in which this determination is made. *(List actions to be taken to resolve insufficiency.)*

**Finding of Available Science Laboratory Equipment for Grades 9-12**

Be it further resolved, laboratory science equipment *[was available or was not available]* for science laboratory courses offered in grades 9-12, inclusive.
