### **Business and Noninstructional Operations DISRUPTIONS**

The County Superintendent and County Board are committed to providing a safe and orderly environment for students, staff, and others.

The County Superintendent or designee shall remove any individual who, by the individual's presence or action, disrupts or threatens to disrupt normal operations at a school campus or any other County Superintendent/County Board facility, threatens the health or safety of anyone on property, or causes or threatens to cause damage to property.

The County Superintendent or designee shall establish a plan describing staff responsibilities and actions to be taken when an individual is causing or threatening to cause a disruption. The plan shall address, as appropriate, visitor registration procedures; campus and site security measures; evacuation procedures; lock-down procedures; possible responses to an active shooter situation; communications within the school and with parents/guardians, law enforcement, and the media in the event of an emergency; and crisis counseling or other assistance for students and staff after a disruption. In developing such a plan, the County Superintendent or designee shall consult with law enforcement to create guidelines for law enforcement support and intervention when necessary.

The County Superintendent or designee shall provide training to staff on how to identify and respond to actions or situations that may constitute a disruption.

Any employee who believes that a disruption may occur shall immediately contact the lead site administrator. The lead site administrator, or designee shall notify law enforcement in accordance with Education Code 48902 and 20 USC 7961 and in other situations, as appropriate.
